**A check may be used for a deposit only if its at min. 7 days before the event. If under 7 days must be paid with cash or credit card! No Exceptions.**

## Rules and Regulations

*Show respect for the driver and follow the driver's instructions.*

*Client is responsible for any damages to the bus/limo or it's equipment, caused accidentally or otherwise.*

*Violence will not be tolerated.*

- We accept cash, credit card, or PayPal.
- Cancellation Policy: If you cancel your booking 7 days prior to your event, you will be responsible for 50% of the rate if we are unable to re-book your date. If cancelled later than 7 days prior to you event you will be responsible for 100% of the rate charged if we are unable to re-book your date.
- Payment of full lease is to be paid to the driver upon arrival unless full payment is received in advance. A \$35 fee will be charged for bad credit card processing.
- Provide complete and accurate postal address for mailing back the deposit check.
- Starting and ending times must be enforced. (Subject to driver and bus/limo availability.)
- All 4 Fun, LLC is not responsible for any lost or stolen articles during the ride or articles left after the ride has ended.
- There is NO SMOKING allowed in the bus/limo.
- Alcoholic beverages are not allowed outside of the bus/limo during the trip.
- Glass beverage bottles are not allowed on the bus. Plastic or cans only.
- The All 4 Fun, LLC driver and/or employee reserves the right to eject any individual(s) whom they deem to be disruptive, intoxicated, pose a safety threat to themselves or others, or are deemed to be using an illegal substance.
- All 4 Fun, LLC is not responsible for underage consumption of alcoholic beverages at any time before, during, or after the ride. Driver has the right to inspect I.D.s and containers of passengers who appear underage.
- All 4 Fun, LLC cannot, by law, supply alcohol to/for clients. Guests must provide their own alcohol.
- For any actions such as fighting, violence, damage to equipment and/or bus/limo, harassment toward the driver, staff, or anyone else in or around All 4 Fun, LLC, the driver reserves the right to terminate the trip. The client will be responsible to find other transportation and forfeits the full fare as a result.
- If a passenger should vomit in or on the bus/limo, there will be a charge of \$100 payable to the driver or charged to the client's credit card. If someone in the bus/limo needs to vomit, inform the driver and (s)he will pull over when safe to do so.
- By signing up for and participating in the ride, the individual agrees that All 4 Fun, LLC and it's employees are not responsible for any claims for injuries, loss, damage, death, liability, criminal or civil litigation for the participating individual arising out of or relating to a ride.
- By signing this contract, the above client agrees to assume full responsibility for any damages to the interior or exterior of the bus/limo that is caused by any individual riding in the bus/limo. The client is liable for the cost to repair any such damage as well as any cost for loss of All 4 Fun, LLC service due to such damage.
- All 4 Fun, LLC is not responsible for injuries or accidents in and around the bus/limo. Alcohol impairs motor skills, balance, and judgment. Clients are asked to remain seated while the bus/limo is in motion. Move about at your own risk. Please use caution on the steps.
- All 4 Fun, LLC is NOT LIABLE in cases of unexpected vehicle breakdowns, accidents, severe weather, or anything that may delay a timely arrival or cause cancellation of the trip. In the event of a cancellation due to mechanical problems, the trip may be rescheduled for another date. The client will be notified as soon as possible to let them know of unexpected problems which may postpone trip times.
